The meeting was called to order by President Dennis Hudson, N2LBT, at 7:07 PM in Olin Hall Rm 101 on the Union College Campus.

Minutes: Paul Siemers, WY2F, made a motion to accept the minutes as published in SARA News. Millie Gittinger, KB2SWR, seconded the motion and it passed unanimously.

Treasurer's Report: George Williams, W2CSN, presented the Treasurer's Report to the Board. Gerry Crawmer, KE2JJ, made a motion to accept the Treasurer's Report as presented. The motion was seconded by Millie Gittinger, KB2SWR, and it passed unanimously.

Budget 2003-2004: George Williams, W2CSN, presented the proposed SARA Budget to the Board. After a short discussion, Tim Long, W2UI, made a motion to adopt the SARA Budget for the current year as proposed. The motion was seconded by Gerry Crawmer, KE2JJ, and it passed unanimously.

New Members: None presented.

Correspondence: Tim Long, W2UI, reported that we had received several membership renewals, several repeater fund drive contributions, a monthly bank statement, and a letter from the ARRL requesting that we continue to sponsor a June VHF Contest Plaque, since the last Board Meeting.

ARRL June VHF Contest Award Plaque: Tim Long, W2UI, reported that SARA had sponsored this plaque for several years now since its' creation. Tim explained that there is a waiting list for plaque sponsors and that if we ever chose to give up sponsorship, that we would probably not be given the opportunity to sponsor it again. The cost of sponsorship is \$67. Millie Gittinger, KB2SWR, made a motion to sponsor the plaque for the upcoming season. Ramsey Seielstad, KC2GMW, seconded the motion and the motion passed.

Repeater Committee: No Report. The Board is awaiting a recommendation from the Repeater Committee on the 220 meter machine.

Public Service: No Report. Upcoming events that we know of are the Stockadeathon on 11/16 and the Christmas Parade on 11/28.

Newsletter: Clark Gittinger, KG2AO, reported that duplicating was done at Leonard Communications.

Membership: Tim Long, W2UI, reported that 37 members who were paid in full through 6/2003 have not renewed yet.

Public Relations: No Report.

Programs: Ramsey Seielstad, KC2GMW, reported that Steve Mendelson was scheduled for Monday. George Williams, W2CSN, reported that a tentative program for the

May meeting might be a Special Event Station program.

Constitution and By-Law Review: No Report.

Broughton Committee: No committee has been formed yet.

Old Business-

Box Trailer: Paul Siemers, WY2F, reported that the leaf springs had been replaced. Paul and Tim also reported that during spring replacement, it was discovered that the trailer frame side rails which are made of 4" X 2" steel box beams, were rusted and rotten. Their condition is much worse than initially thought, and they are in need of replacement within the year. Replacement steel can be obtained for approximately \$50 and another \$50 is estimated for welding materials. The Board agreed that this funding was already budgeted under Field Day Expenses and that no further approvals were required.

Dues Reminder Letter: Tim Long, W2UI, presented the format of a reminder notice that would be mailed to those SARA members who were in good standing as of 6/2003 but had not yet renewed their membership for 2004. George Williams, W2CSN, made a motion to mail the notices. Ramsey Seielstad, KC2GMW, seconded the motion and it passed unanimously.

New Business:

Broadband over Power Lines: Carl Lester, K2YR, encouraged club members to support the ARRL efforts to oppose this threat to ham radio. Carl distributed CD copies of the video and PowerPoint presentation that the ARRL had composed which show how serious and devastating these signals are in test areas that exist today. Carl explained that the spectrum from 2 to 80 MHz would become almost useless. Gerry Crawmer, KE2JJ, made a motion to donate \$250 to the ARRL Spectrum Defense Fund allocated to oppose BPL. Carl Lester, K2YR, seconded the motion and it passed unanimously.

Master II Base Stations: Dennis Hudson, N2LBT, reported that the NYS Police Radio Warehouse in Scotia had given SARA 12 Master II base stations and that they were presently located in the Capital Digitronics site. Dennis explained that these radios would provide many years of spare parts for the current K2AE repeater systems.

Millie Gittinger, KB2SWR, made a motion to adjourn the meeting at 8:43 PM.

Net Control Speaks Every Sunday

Every Sunday afternoon, the Net Control Stations for Schenectady County RACES, ARES and Skywarn meet for tests of their stations. It is a good chance for local amateur radio operators to both check-in to the net and to say hello to one another. All amateurs are welcome, no memberships are required. It is a radio friendly and orderly group.

Net protocol is very different from random QSO contacts. Each of the Sunday nets is initiated by a Net Control Station. This station varies from week to week. They are lightly structured with stations following check in protocol. . When the net control station calls, you respond with your call sign using proper radio phonetics, stating whether you are mobile, portable or fixed location. Once a list of stations has been assembled, the net control station will ask stations for input to the net - announcements concerning club meetings, public service events, weather reports, and general amateur radio information. Include your name, location, and power output. Stations are requested to stay on frequency until the net control station has had time to call each of the check in stations and not leave the net without first requesting permission from the net control station. Time allowing, the net control station will call stations on the list more than once, usually in the order of check in.

The Schenectady County Radio Amateur Civil Emergency Services Net is one of the few RACES nets to operate on HF high frequency without the use of a repeater. The net can last anywhere from 5 to 45 minutes depending on the number of check-in stations. Some parts of the net tend to be more formal than others. The order and control of stations on the air is exactly what makes it a net rather than just a group of amateur radio operators. Schenectady RACES has a long history, is deeply rooted with the Schenectady Amateur Radio Association and the heavy winter storms of 1930. If you are new to amateur radio or if you have been on the air since the beginning, put the ARES/RACES nets on your weekly calendar. It is a great way to meet old friends, make new ones, take pride in your station and to take part in the Amateur Radio Service. Look for times and frequencies in this newsletter.


