The FCC and Peter Drucker

Let's look at what the FCC permits us to talk about "on the air" and what is not permissible. FCC Part 97.1 Basis and Purpose. (Paraphrased)

The rules and regulations designed to provide an amateur radio service having a fundamental purpose as expressed in the following principles.

A. Recognition and enhancement to the public as a voluntary noncommercial communications service particularly in respect to providing emergency communications.

B. Continuation and extension: to contribute to the advancement of the radio art.

C. Encouragement and improvement: through rules for advancing skills in communications and technical phases of the art.

D. Expansion of: trained operators, technicians, and electronics experts.

E. Continuation and extension of the amateur's unique ability to enhance international goodwill.

Part 97.101 - 121 Station Operations Standards.

The rules in this section talk about what can and what cannot be transmitted.

“The most important thing in communication is hearing what isn't said” -*Peter Drucker*

Let's examine what isn't being said:.

ARRL Study Guides, Other study guides and FCC applications. What we do not see is any material covering is a person's Race, Ethnicity, Religion, Sexual preference, Politics or Political affiliations.

These subjects should not be part of any amateur communication. They are highly controversial. They bring down everyone's respect for the hobby and cause ill will.

By “everyone” we can include amateurs and non-amateurs. It is detrimental to the hobby. Any politician who happens to listen certainly won't be willing to support amateur radio. Parents will not let their children learn or encourage them toward amateur radio, nor will anyone listening want to join or support the hobby.

Back when I was first licensed, I asked Howard Lester, W2ODC, sk, “What is good amateur radio practice?” His reply was, “always behave as a gentleman, never say anything that anyone would take offense to.” Howard also mentioned that Amateur Radio is not for everyone!

Let's all be a little more careful in what we say and how we say it.

Walt Schick, W2KE, SK

The community and amateur radio suffered a great loss with the passing of Walt Schick, W2KE, on September 27. Walt was 101 years old at the time of his passing. He was born in Ohio and came to Schenectady in 1926. Dr. Schick, as he was known by many, was a dentist and practiced his profession on upper Union Street for 33 years.

Walt participated in amateur radio with great enthusiasm like he did most things in his life. He studied theory and the hardware so that he became very proficient in all aspects of radio. He gladly shared his knowledge with others, helping them repair equipment and solve the problems with their stations. His was one of the few stations in the area to have a quad antenna which he used, along with the other fine equipment in his station, to become a member of the DXCC honor roll.

Walt worked closely with the American Red Cross to set up a station to operate on two meters and help them with emergency communications when the Red Cross had offices in Schenectady. Walt was a fine gentleman and will be missed by all who knew him.

Clubs are always looking for operating events and opportunities that excite and motivate their members to be active, especially on HF. This year's <http://www.arrl.org/sweepstakes> ARRL November Sweepstakes certainly fits the bill and – for the first time in years – the bands will have plenty to offer Technician license-holders, too! Sweepstakes – or “Sweeps” among friends – is a contest in which modest stations can do very, very well. There's no need for giant towers and antennas or legal-limit amplifiers – a backyard dipole or vertical and a “barefoot” HF rig will do just fine. In fact, SS is one contest in which antennas can be too high!

Because Sweepstakes brings out so many US and Canadian operators, it is very popular for friendly “contests within a contest” between clubs and between club members. A club contest to work the most sections, make Worked All States, or ring up the highest score is a nice way to wrap up the season with awards being presented at the year-end meeting. Many clubs have a friendly competition with other nearby clubs for local bragging rights. Even small clubs can get into the action on a national scale in the Local category of the <http://www.arrl.org/general-contest-information> ARRL Affiliated Club Completion.

<http://collegearc.org/College> clubs can participate in two ways. The first is to submit a score in the School Club category of the main competition. With its 30-hour time limit, the shared-operating nature of the category fits right in with the busy fall semester. Give the Phone weekend (Nov 19-20) a try before heading home for Thanksgiving break! The second is to participate in the <http://www.collegiate->

[championship.org/Collegiate](http://www.collegiate-championship.org/Collegiate) Championship, sponsored by Ken Harker, WM5R. Ken has compiled a long list of <http://www.collegiate-championship.org/conferences/yearly> winners for each of the NCAA Division I Conferences – has your school's club participated? The website is currently being updated with the 2010 scores and we need some help sorting out the current conference assignment for the record-holders - any volunteers? Finally, for a relaxed “practice” opportunity, try the ARRL's <http://www.arrl.org/school-club-roundup> School Club Roundup from Oct 17-21.

Did we mention the opportunities for Technician licensees? Techs have a large chunk of 10 meters available to them on both Phone (28.3-28.5 MHz) and CW (28.0-28.2) but in recent years, there hasn't been much activity due to quiet solar conditions. Lately, the solar flux has been kicking up to 120 and higher, meaning that 10 meters opens up coast-to-coast and beyond! If your club's Techs have been wondering what all the fuss is about 10 meters, be sure to encourage their activity during Sweeps. Perhaps one of those intra-club challenges we were talking about?
