FCC to Drop Morse Testing for All Amateur License Classes

In an historic move, the FCC has acted to drop the Morse code requirement for all Amateur Radio license classes. The Commission today adopted a Report and Order (R&O) in WT Docket 05-235. In a break from typical practice, the FCC only issued a public notice at or about the close of business and not the actual Report and Order, so some details, including the effective date of the R&O, remain uncertain. "This change eliminates an unnecessary regulatory burden that may discourage current Amateur Radio operators from advancing their skills and participating more fully in the benefits of Amateur Radio," the FCC said. The ARRL had asked the FCC to retain the 5 WPM for Amateur Extra class applicants only. The FCC proposed earlier to drop the requirement across the board, however, and it held to that decision in today's R&O.

Perhaps more important, the FCC's action in WT Docket 05-235 appears to put all Technician licensees on an equal footing: Once the R&O goes into effect, holders of Technician class licenses will have equivalent HF privileges, whether or not they've passed the 5 WPM Element 1 Morse examination. The FCC said the R&O in the Morse code docket would eliminate a disparity in the operating privileges for the Technician and Technician Plus class licensees. Technician licensees without Element 1 credit (ie, Tech Plus licensees) currently have operating privileges on all amateur frequencies above 30 MHz.

"With today's elimination of the Morse code exam requirements, the FCC concluded that the disparity between the operating privileges of Technician Class licensees and Technician Plus Class licensees should not be retained," the FCC said in its public notice. "Therefore, the FCC, in today's action, afforded Technician and Technician Plus licensees identical operating privileges."

Ham radio enthusiasts come in loud and clear Largest amateur group in region is ready to respond to emergencies

SCHENECTADY -- Most mornings, the topic of conversation crackling over the airwaves is mundane: How's the weather in northern Canada? How's your family in Australia? But when the power goes out, said Hal Post, "That's when the fun begins."

Post, of Middle Grove, is the president of the Schenectady

Amateur Radio Association, a group of 100 or so volunteers who literally watch the skies and keep their battery-operated radios on the air in the event of an emergency. SARA is the largest and most active amateur radio group in the Capital Region.

The club dates to 1930, almost as old as radio itself. The 100th anniversary of the first voice radio broadcast was Dec. 24. On Christmas Eve 1906, Canadian Reginald Fessenden broadcast a program of Christmas music and Bible readings to ships at sea.

While it was on the cutting edge then, the technology is still relevant today, according to local "hams," as amateur radio operators call themselves.

"When there's no power, no phone lines, no Internet, we can still get through," Post said. Hams are still called on to relay emergency information to police, fire and ambulance crews whenever there is widespread disaster.

The most recent examples included Hurricane Katrina and the 9/11 attacks. Both catastrophes saw volunteers from the Capital Region head to the affected areas to help with communication, broadcasting information on emergency shelters, and to help emergency crews speak to each other when the first responders' own radios weren't working.

Public service is a requirement of having an amateur radio license, and the radio operators frequently practice their skills, holding drills and field days where operators use portable radios to make contact with local command posts, as well as with other operators around the country.

The radios are an important resource to have when all else fails, said Daniel Fiorillo, who was Schenectady County's emergency services coordinator until his retirement last year.

"We've had them monitoring the river level on several occasions," Fiorillo said. About five years ago, flooding to a building that housed telephone equipment cut off phone service for most of the city. Amateur radio operators were stationed at points around the city, ready to call on police or fire companies if someone was stymied when calling 911.

"You could go for years and not call on them," Fiorillo said. "Then you have something like the hurricanes, or flooding..."

But it's hard to keep people, especially kids, interested in chatting with other radio operators in, say, Australia, when anyone can wander into an online chat room and do much the same thing.

But Brian Casey, a retired Colonie police officer, has hopes for the future. He is trying to organize an amateur radio class for kids at the Colonie Family Recreation Center, where he has worked for the last three years.

"Kids can sit in front of the boob tube and learn what? Nothing," he said. "With the radios, it's fun, and one of these days a kid might have his own 'shack' and be able to help out the community in an emergency," Casey said.

So far, it's been a tough sell, with just a handful of kids expressing interest. But he hasn't given up yet.

The New York Times reported that more than 660,000 Americans have amateur radio licenses. The American Radio Relay League, the umbrella group to organizations like SARA, has about 150,000 members.
